



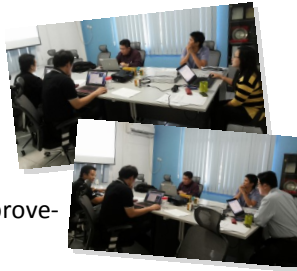
## WELCOMING NEW VESSELS
